The under mentioned candidate who has been selected for appointment as Trainee Junior Engineer/C&W in Pay Matrix Level-06 in Mechanical Department of PGT Division against DRQ through GDCE by RRC/MAS and having been accepted the terms and conditions stipulated in this office offer of appointment and having medically found fit in AYE-THREE category is appointed as Apprentice Junior Engineer/C&W on a monthly stipend of Rs.35400/- per month plus dearness allowance or salary plus usual allowance as admissible under rules in force from time to time as opted by the employee and directed to undergo 12 months initial training for absorption against regular working post. He is opted salary.

He will be directed for mandatory initial training at MDDTI/SBC which will be commenced on 08.12.2025.

The above appointment is subject to the following conditions:-

- 1) After successful completion of training, he will be on probation for a period of two years.
- 2) His service is purely temporary and he will not be entitled to any notice of termination of service or pay in lieu thereof if such termination of service is due to expiry of the officiating capacity/vacancy or due to removal or dismissal as a disciplinary measure after compliance with provisions of clause (2) of 311 of the Constitution of India, Otherwise his service is liable to be terminated on one month notice period in terms of IREM/Vol-I Chapter-XV.
- 3) In the event of being retained in Railway Service after the period of one year apprenticeship

training, and on successful completion of training and passing in the suitability test at this end of training on absorption in regular post, his service thereafter will be on temporary basis, the 1st, 2nd years of which (except the period of training) will be deemed to be on probation.

- 4) In terms of Railway Board's letter No.2004/PC11/21/1 dated.10.01.04 he is coming under Contributory Pension Scheme. All the new recruits in the Central Government Service joining Govt. Service with effect from 01.01.04 shall compulsorily make contribution to the Government. The contribution is payable by the Railway servants towards the Tier I will be recovered at the rate of 10%of Basic pay and DA from their salary every month. In addition to above pension account, each Govt.servants may also have Tier-II withdraw able account at their option.
- 5) In terms of RBE No. F(E)III/2025/UPS/1 dt.18.03.2025 & RBE No. 22/2025 "The existing Central Govt. employees under NPS, on the effective date of operationalization of the Unified Pension Scheme option, as well as the above candidate can choose to either take the UPS (Unified Pension Scheme) option under the National Pension System or continue with the National Pension System without the Unified Pension Scheme option. In case they chooses the UPS option, all its stipulations and conditions shall be deemed to have been opted for and such option once exercised, shall be final.
- 6) In terms of PCPO/MAS letter No. P(R) 500/P/UPS dt. 21.03.2025 (PBC No.65/2025) & PCPO/MAS letter No. P(R) 500/P/UPS dt. 01.04.2025 (PBC No.70/2025). The employees who were covered under NPS and become eligible under Chapter-II of the PFRDA gazette notification dated 19.03.2025 are advised to submit their option for enrolling to Unified Pension Scheme (UPS). The corresponding rule for Fundamental Rules 56 (j) mentioned in the notification is Rule 1802 (a) of IREC.
- 7) The employee is advised to go carefully through the details of the scheme (UPS) and its operationalization and due care may be taken before submitting the request since option once submitted is final and irrevocable.
- 8) The employee shall submit their option preferably through online mode in the following link <https://enps.nsdl.com/ NPS / UPSOnlineMigration.html>. In case of any technical problem, the employee can also submit the physical request through Form A2 directly to NPS section.
- 9) This appointment order is purely provisional subject to the receipt of verification report from Civil/Police authorities regarding their character and antecedents. If anything, adverse in the said report is found regarding their suitability for appointment, their services are liable to be terminated forthwith without any notice.
- 10) He will be responsible for the government Money, Goods, Stores and other properties that may be entrusted to him in the discharge of their official duties.
- 11) He should be prepared to serve anywhere on the Railway system.
- 12) Any excess payment found to have been made in regard to this order is required to be refunded, when detected later by Railway.
- 13) The period from 24.11.2025 to 03.12.2025 may be treated as duty waiting for orders.
- 14) All other terms and conditions stipulated in this office offer of appointment stands good.
