- (iii) It may be ensured that the employees are free from DAR/SPE/Vigilance cases on the date of their relief from respective unit.
- (iv) The Basic Pay, Pay Level, Designation and seniority of the aforesaid employees remain unchanged as the Nursing cadre of Southern Railway and ICF Hospitals are centrally controlled at HQs/Southern Railway.
- (v) They should vacate the Railway quarters, if in occupation, before relief and within one month from the date of receipt of this advice, as per Railway Board's letter No. E(G) 2000 QR1-23 dated 01.06.2001.
- (vi) The aforesaid transfer order is governed by the instructions circulated vide this office letter No.SR-HQ0HR(MEDL)/42/2021-O/o Ch OS/Medl/Pers/HQ/SR dated 29.04.2022 and the same may also referred to before postings to Health Units within the Division. Any changes may be informed to this office immediately.
- (vii) The date of relief/reporting of aforesaid employees may be advised to all concerned without fail.
