The under-mentioned employee was removed from service with effect from 08.08.2024 by the Disciplinary Authority & Sr.DCM/PGT as per the Penalty Advice cited at reference (1) and the Memorandum cited at reference (2). Further, on appeal, ADRM-II/PGT, being the Appellate Authority, has confirmed the penalty imposed by the Disciplinary Authority.

The Chief Commercial Manager/Passenger Services & Revisionary Authority has further modified the penalty and ordered you are re-instatement into Railway Service, with reduction to the post of Senior Ticket Examiner in Pay Matrix Level-5, with basic pay of Rs. 29,200/-, with immediate effect for a period of two (2) years.

On expiry of the penalty period, you will regain your original seniority and pay in the higher time scale of pay, grade, post, or service from which you were reduced. You are also warned to refrain from committing such mistake in future. Any recurrence will be viewed seriously and severe action will be taken against you.

Accordingly, for reinstatement, the employee reported to this office on 10.11.2005 and was directed to CMS/RH/PGT for medical examination. He has been posted on reinstatement as Sr. TE at the station mentioned against his name
