1. The employee will take the seniority in the new seniority unit to which he is transferred as per extant rules applicable to Inter Division Mutual transfer (ie;) he will either retain his own seniority or take the seniority of the Railway servant with whom he sought mutual transfer, whichever is lowest.
2. He will not seek re-transfer to his parent Unit/Railway at a later date.

3. He is not eligible for any transfer benefits on transfer account as the transfer is agreed at his own request.
4. He will retain his lien in the Parent Departments seniority unit until he is permanently absorbed in the new seniority unit to which he is posted or for a period of two years whichever is earlier.
5. He should be free from DAR/SPE/Vig cases as on date of his relief.
6. He has to vacate quarters, if, any occupied by him. If he wishes to retain the quarters as per extant rules, he has to apply to concerned divisions in Personnel Branch for retention of quarters in the old station. Retention of quarters without permission/beyond permission will attract deduction of damaged rate of rent.
7. In terms of Railway Board's letter, No.E(NG)-1/2006/TR/6 dated 21.04.2006 (RBE No: 53/2006), no request for back tracking from the above employee from the mutual exchange to be entertained in any circumstances.
