The above upgradation under the MACP Scheme is granted subject to the following conditions:

1. The upgradation to Pay Matrix Level-08 for the post of Chief Ticket Inspector is purely provisional.
2. No DAR / SPE / Vigilance cases are pending against the employees, and no penalty is in force as on date.
3. There shall be no change in the nomenclature/designation, duties, responsibilities, or classification of the post after upgradation, and the posts shall continue to remain classified as Group 'C'.
4. The above upgradation shall be counted as offset against the financial upgradations admissible under the MACP Scheme, as per the extant instructions governing MACP regulations.
5. In cases where financial upgradation under ACP/MACP has already been granted and pay has been fixed accordingly, no further pay fixation will arise on account of this upgradation.
6. Employees are permitted to exercise an option within **one month** for pay fixation under the provisions of Rule 1313 FR 22(I)(a)(1) of IREC Vol-II and PBCNo.308/2019 dated 07.01.2020.

If an employee does **not** exercise the option within the stipulated period, pay will be fixed as per Rule 1313 FR 22(I)(a)(1) of IREC Vol-II, and **no further revision of option** will be permissible, in terms of Railway Board's Letter No. VII/2016/1/6/2 dated 31.07.2017 (PBC No.115/2017).

7. In terms of Railway Board's Letter No. 2018-E(SCT)I/25/9 dated 03.06.2019 (PBC No.141/2019), the upgradation ordered above is purely provisional and subject to the final outcome of ongoing litigations/court cases on the subject.
