Conditions:

1. The employees transferred on request ground are not eligible for any transfer privileges.
2. The existing request registrations of the above-mentioned employees for transfer to other stations, if any, shall stand automatically cancelled upon issue of this order
3. The **date of relief and joining** of the above employees may be intimated to all concerned in time. The details of employees who do not join at the transferred station within 15 days from the date of relief may also be **communicated to all concerned**.
4. The employees under orders of transfer should vacate the Railway Quarters immediately on relief, if any are occupied by them . If they propose to retain the quarters as per the extant orders, they should apply in time for retention and obtain prior permission. Retention of quarters without or beyond permission will attract deduction of rent at the damage rate.
