3. He is eligible to exercise option for fixation as mentioned below:
 - a) pay fixation under Rule 1313 (1) (a) of the Indian Establishment Code Volume II (VI Edition 1987 - 2nd Reprint 2005) FE 22(1) (a) (i)to get his pay fixed in the grade pay either from the date of his upgradation.
 - or
 - b) From the date of his next increment from 1st July of the year. The pay and the date of increment would be fixed in accordance with clarification No.2 in the Railway Board's letter No.PC-

In case the employee does not exercise any option within one month from the date of issue of this O.O, it may be noted that his pay will be fixed as 3 (a) above.

4. Any excess payment found to have been made in regard to this order is required to be refunded, when detected later by Railways.
